



Dear Kingston Plantation Contractor:

**2025 CONTRACTOR DECALS
HOW TO GAIN ACCESS TO KINGSTON PLANTATION**

All persons and companies providing services of any type (i.e. construction, repair, cleaning, management, etc.) on Kingston Plantation are required to display a valid Contractor decal on their vehicle(s) windshield(s). Contractor decals are **neither refundable, nor transferable**.

It is your responsibility to obtain a 2025 Contractor decal, **prior** to attempting entry onto the Plantation. Contractors not displaying the decal will be denied access to the Plantation. Decals may be purchased in the KPMA office located in Suite H of the Market Place Monday to Friday between 9 a.m. – 12 Noon and 1 p.m. – 4 p.m. Final customer at 3:45 p.m.

The cost for 2025 Contractor decals are:

- 1 to 15 decals - **\$50 each**
- 16 or more purchased at the same time - **** \$40 each ****

**** To qualify for the reduced rate all decals must be purchased and picked up at the same time ****

To obtain 2025 Contractor Decals, please:

- Legibly complete and return the decal request form (on the reverse side of this letter)
- Provide a copy of your valid Photo Driver's License
- Provide a copy of your valid Vehicle Registration
- Provide a copy of your valid Vehicle Insurance Identification Card
- Remit payment for decal(s) requested – **Credit/Debit Card or Check made payable to KPMA.**
Our office no longer accepts cash payments.

Contractor decals will not be issued without all of the above required documentation and payment. **At any time, Contractor Decals may be revoked for expired documentation or failure to abide by Plantation speed limits, parking rules and Contractor rules. No warnings will be issued**

Decals must be permanently affixed low on the **INSIDE** of the drivers' side windshield. **Decals are neither refundable, nor transferable.**

Please provide a copy of your valid driver's license, valid vehicle registration and valid vehicle insurance ID card. Upon receipt of the completed form, supporting documentation and payment, decals will be issued.
Payment types accepted: Credit / Debit cards and checks made payable to KPMA.

Contractor Decals may be revoked at any time for expired documentation or failure to abide by Plantation speed limits, parking rules and Contractor rules. Contractors MAY NOT DISPOSE OF CONSTRUCTION MATERIAL AT KINGSTON PLANTATION. ALL DEBRIS MUST BE REMOVED FROM KINGSTON PLANTATION ON A DAILY BASIS.
