



## **2026 CONTRACTOR DECALS** **REQUIREMENTS TO GAIN ACCESS TO KINGSTON PLANTATION**

All persons and Companies providing services of any type (i.e. construction, repair, cleaning, management, etc.) on Kingston Plantation are required to display a Valid Contractor Decal on their vehicle(s) **TOP, (Outside), drivers' side windshield** or **display a Day Pass Hang Tag visibly off your rear view mirror.** Contractor decals and Hang Tags are **neither refundable, nor transferable.** **Decals and Hang Tags are vehicle and driver specific.** Decals or Hang Tags that are transferred between vehicles is **strictly prohibited** and will become **VOID immediately** and there will be **no refund** under any circumstances. Day Passes must be purchased at the KPMA office daily.

It is your responsibility to obtain a 2026 Contractor decal or Day Pass, **PRIOR** to attempting entry onto the Plantation. Contractors not displaying the Decal or Day Pass Hang Tag will be **denied** access to the Plantation. Decals and Day Passes can be purchased in the KPMA office located at 9776 Kings Road - Suite H; in the Market Place (Monday to Friday between 9 a.m. – 12:00 & 1:00 – 4:00p.m.)

### **The cost for 2026 Contractor decals are:**

- Day Pass Hang Tags - \$10.00
- 1 to 15 decals - **\$50 each**
- 16 or more purchased at the same time - **\*\* \$40 each \*\***

**(To qualify for the reduced rate all decals must be purchased and picked up at the same time)**

### **To obtain 2026 Contractor Decal(s) or Day Pass Hang Tag you will need the following Information:**

- **Legibly**, complete and return the Decal request Form
- Provide a copy of your **Valid** Photo Driver's License
- Provide a copy of your **Valid** Vehicle Registration
- Provide a copy of your **Valid** Vehicle Insurance Identification Card
- Remit payment for Decal(s) requested – **Credit/Debit Card or Check made payable to KPMA.**  
**(Our office no longer accepts cash payments)**

**Contractor Decals/ Day Passes will not be issued without ALL of the above required documentation and payment.** At any time, Contractor Decals/Day Pass may be revoked for expired documentation or failure to abide by Plantation speed limits, parking rules and Contractor rules. **NO warnings or refunds will be issued!**

## **2026 CONTRACTOR DECAL REQUEST FORM**

To obtain **2026** Contractor Decal to access Kingston Plantation to perform construction/repair/housekeeping/management, services; please return this completed form and all supporting documentation with payment to:

The cost for **2026** Contractor decals:

- Day Pass Hang Tag - \$10.00 each per day (Can NOT be purchased in advance)
- 1 to 15 decals - \$50 each
- 16 or more purchased at the same time - \$40 each

Decals must be permanently affixed on the **TOP (OUTSIDE)** of the **drivers' side windshield** and Day Pass Hang Tags must be hung visibly off the rear view mirror. **Decals and Day Pass Hang Tags are neither refundable, nor transferable and are driver specific.**

Please provide a copy of your **Valid driver's license, Valid vehicle registration** and **Valid vehicle insurance ID card**. Upon receipt of the completed form, supporting documentation and payment, decals will be issued. Day Pass Hang Tags must be purchased in the KPMA Office.

(Payment types accepted: **Credit / Debit cards and checks made payable to KPMA. NO CASH ACCEPTED.**)

Contractor Decals and Day Passes may be revoked at any time for expired documentation or failure to abide by Plantation speed limits, parking rules and Contractor Rules. Contractors MAY NOT DISPOSE OF CONSTRUCTION MATERIAL AT KINGSTON PLANTATION. ALL DEBRIS MUST BE REMOVED FROM KINGSTON PLANTATION ON A DAILY BASIS.
